## Craig Biggio

Born December 14, 1965 in Smithtown, New York, Craig Biggio was a football star at Kings Park High School on Long Island and seemed destined to become one of the top recruited running backs in the nation. But his grades did not measure up to his achievements on the gridiron.

Biggio settled on a partial baseball scholarship to Seton Hall University and quickly established himself as a proprospect. In 1987 he was taken in the first round (22nd overall) by the Houston Astros in the MLB draft. After just 141 minor league games over parts of two seasons, during which he compiled a .344 batting average, Biggio was called up to the Astros in June of 1988.

The 1990s were a watershed time in Biggio's personal and professional lives. In February 1990, he married his girlfriend, Patty Egan, who he met while at Seton Hall. The couple has three children, sons Conor and Cavan and daughter Quinn. By 1991, Biggio was a .295 hitter who had made his first all-star team. In 1992, he became Houston's second baseman, appearing in all 162 games and making his second all-star team. Biggio joined the 3,000 hit club in 2007, his last year in the big leagues. In all, he spent 20 seasons with the Astros, hitting .281 with 1844 runs scored (15th all time) 291 home runs and 414 stolen bases. He won five Silver Slugger awards and four Gold Glove awards. He is the only player in baseball history with at least 3,000 hits, 600 doubles, 400 stolen bases and 250 home runs.

"Being a parent, a dad, is the most important thing I'll ever do", says Biggio. Looking back on his career, he recalled "I tried to play the game hard and play the game right every single day. I remember where I came from and I remember how hard it was to get to the big leagues and I try to go out there and play every game like it was going to be my last game."

In addition to his on field accomplishments, Biggio won the Branch Rickey Award for community service in 1997 and, in 2007, the Roberto Clemente Award, which is given to the player who best exemplifies the game of baseball, sportsmanship, community involvement and the individual contributions to his team. He was also the recipient of the Hutch Award and Thurman Munson Award, both focusing on community service. He has been an active supporter of Texas Children's Hospital, The Miami Project and Astros in Action. Biggio has been a supporter and national spokesperson for the Sunshine Kids Foundation for over 25 years. He helps by raising awareness for the organization, holding celebrity golf tournaments and hosting annual parties at Minute Maid Park. Craig also makes personal visits to the Sunshine kids and their families. He has raised over 5 million dollars for the Sunshine Kids organization.



## Rufus P. Cormier


Rufus P. Cormier, a native of Beaumont, Texas, attended Southern Methodist University as one of the three members of the second class of African American scholarship athletes to play football in the Southwest Conference. At SMU, he was co-captain of the varsity football team, named outstanding defensive player in the 1968 Bluebonnet Bowl, and named to the second consensus All-Southwest Conference team.

After graduation from SMU with honors and receiving the Avella Winn Hay Award as outstanding senior student in 1970, he attended Yale Law School, graduating in 1973. He then served as Special Assistant to John Doar, Counsel to the House Judiciary Committee for the Nixon Impeachment Inquiry, before joining Baker Botts L.L.P. as a corporate and finance lawyer, where he became the first African-American partner in a large Houston law firm in 1981.

In addition to his legal practice, Rufus has been involved in numerous civic, philanthropic and educational activities. His affiliations have included serving or having previously served as Chairman of the Board of Regents of Texas Southern University, as a member of the Bush Clinton Coastal Recovery Fund Committee, the Executive Committee of the Board of Visitors of the MD Andersen Cancer Center, the Executive Committee of the Board of Directors of the Center for Houston's Future, the Executive Board of SMU's School of Law, the Board of Trustees of St. John's School, the State Bar Grievance Oversight Committee, the Executive Committee of the Yale Law School Association, the Yale University Council Committee on Yale Law School and the Houston-Harris County Sports Facility Public Advisory Committee, as Vice Chairman of the Board of Directors of the Houston Bar Foundation and the American Red Cross (Greater Houston Chapter), as a commissioner of the Houston City Planning Commission, and as a member of the Boards of Directors of the Memorial Hermann Healthcare System, the Center for American and International Law, the Texas Business Hall of Fame Foundation and the United Way for the Texas Gulf Coast.

Honors Rufus has received include Community Partners' Father of the Year Award, the National Conference for Community and Justice's Humanitarian Award, the SMU Letterman Association's Silver Anniversary Mustang Award, the Anti-Defamation League's Karen H. Susman Jurisprudence Award, the Houston Bar Association Auxiliary's Leon Jaworski Award, and the Spouses of Houston Barristers' Legal Legend Award; selection by the Texas Jaycees as one of its Five Outstanding Young Texans and by Texas Monthly and Law and Politics magazines as a Texas Super Lawyer; and listing in The Best Lawyers in America.

Rufus and his wife, Yvonne Clement Cormier, M.D., Ph.D., have two adult children, Geoffrey Cormier, who is in the energy business, and Claire Cormier Thielke, who works in the real estate development sector.



## David Poplack, M.D.

David G. Poplack, M.D., has served as Director, Texas Children's Cancer Center since 1993. He holds the Elise C. Young Chair of Pediatric Oncology and is Chief of the Hematology-Oncology Service, Pediatric Department, Baylor College of Medicine. Dr. Poplack leads the country's largest Pediatric Hematology-Oncology program.

Dr. Poplack is a graduate of Tufts University. He received his M.D. from Boston University School of Medicine, completed his pediatric internship at Stanford University, his pediatric residency at Children's Hospital in Boston and his pediatric hematology-oncology fellowship at the National Cancer Institute in Bethesda, Maryland. Prior to joining Texas Children's Hospital and Baylor College of Medicine, Dr. Poplack was Deputy Branch Chief of the Pediatric Branch, National Cancer Institute.

Dr. Poplack is internationally recognized as a leader in the field of pediatric cancer. He has authored more than 365 original articles and book chapters in the field. He is co-editor of Principles and Practice of Pediatric Oncology, the leading textbook of pediatric oncology, which is in its seventh edition. Dr. Poplack has served on many national and international committees, including panel appointments at the National Institutes of Health, the F.D.A. and the Institute of Medicine and as an appointed member of the National Cancer Institute's Board of Scientific Counselors. In 2016, Dr. Poplack was awarded the American Society of Pediatric Hematology-Oncology Distinguished Career Award as well as the Hyundai Hope on Wheels Lifetime Achievement Award.

Over the past 25 years Dr. Poplack has built Texas Children's Cancer and Hematology Centers from a small program with 6 faculty and 42 staff into the largest program of its type in the country with over 190 faculty, nearly 1000 staff and 46 state-of-the-art research laboratories!

Dr. Poplack is the developer of the Passport for Care, a unique, web-based resource that provides childhood cancer survivors with a personalized plan to guide their long-term follow-up. This system, available on survivors' smart phones, is being used by tens of thousands of survivors nationwide.

Dr. Poplack also is the Director of Texas Children's Hospitals' Global HOPE (Hematology-Oncology Pediatric Excellence) program. This transformative, capacity building program is establishing seven Centers of Excellence in Pediatric Cancer and Hematology care in six Sub-Saharan African countries.

Dr. Poplack is known for his mentorship. He has trained many of the current leaders in the field of pediatric hematology-oncology. He and his wife, June, have three children and three grandchildren.

## Manish N. Shah, M.D.

McGovern Medical School and Children's Memorial Hermann



Manish N. Shah, M.D. is an Assistant Professor of Pediatric Neurosurgery and Director of Pediatric Spasticity and Epilepsy Surgery at McGovern Medical School and Children's Memorial Hermann Hospital. His is an academic pediatric neurosurgeon-scientist with research and clinical interests in the etiology, pathogenesis, diagnosis and treatment of cerebral palsy and epilepsy. He earned an A.B. degree in Physics from Princeton University with a certificate in Biophysics and was elected to the Sigma Xi Scientific Research Honor Society. At Princeton, he worked in the laboratory of Professor Robert Austin and co-authored his first basic science paper pertaining to the design and creation of a micro-fabricated magnetic cell sorter for the inexpensive separating of magnetically tagged cells of interest, such as tumor cells and fetal blood cells. He then obtained an M.D. degree at Vanderbilt University and was elected to the Alpha Omega Alpha honors society. At Vanderbilt, he worked for three years in the laboratory of Professor Bruce Carter studying c-Jun and JNK signaling in embryonic mouse dorsal root ganglia as a model for diabetic neuropathy. He next trained for seven years as a neurosurgical resident at Washington University in St. Louis, a historically, internationally regarded program for educating neurosurgeon-scientists. While there, he was awarded an NIH T32 postdoctoral fellowship, where he worked in the laboratory of Professor Marcus Raichle, a prominent Kavli-award-winning

functional neuroimaging scientist who discovered the default mode network of the brain, along with Professor Avi Snyder. There he learned the complexities of resting state functional MRI analysis in children with epilepsy, co-first-authored a PNAS publication entitled "The Role of Testing State Functional Activity in Human Brain Development", providing the first direct evidence that normal resting state brain network architecture may be necessary for normal development. During his training, Dr. Shah won the Medical Student Teaching Award as well as the AANS Annual Meeting First Prize for a Pediatric Poster. After residency, he completed a clinical fellowship with Professor Tae Sung Park at St. Louis Children's Hospital to further his sub-specialization in pediatric neurosurgery. There he learned the SDR technique and, most crucially, patient selection from Dr. Park, a world-renowned expert in the treatment of cerebral palsy with SDR who has successfully helped almost 4,000 spastic children.

After completing his fellowship, he was recruited to McGovern Medical School and MD Anderson to create and direct a team to treat children with spasticity and cerebral palsy, the Texas Comprehensive Spasticity Center, which has successfully evaluated and treated over 300 children from the greater Houston area in three years. His research expertise in pediatric functional neuroimaging, pediatric neurosurgery, as well as clinical experience in quality improvement and patient safety is directly related to the aims of the proposed research in children with cerebral palsy. He has published 19 articles in highly-respected clinical and basic science journals and written a textbook chapter on congenital spine abnormalities. Dr. Shah has also served as an ad-hoc reviewer for a number of neurosurgery journals. Dr. Shah currently has an NIH LRP award from the Eunice Kennedy Shriver National Child Health and Human Development for his CP research. He has been listed in Houstonia's Top Doctors for the last 3 years and was named a Texas Super Doctor Rising Star this year. In 2017, he won the prestigious AANS Young Neurosurgeon Committee's Public Service Citation for his five years of neurosurgical mission work treating children with hydrocephalus at Project MediShare in Port-Au-Prince, Haiti. Dr. Shah also co-directs the neurosurgery medical student rotation at McGovern Medical School.

## Sanjiv Harpavat, M.D., Ph.D.

Baylor College of Medicine and Texas Children's Hospital



Dr. Harpavat practices at Texas Children's Hospital and cares for children with biliary atresia, the most common reason for organ transplantation in pediatrics. His research takes a multi-disciplinary approach to improving our understanding of the disease. Dr. Harpavat is currently testing a novel medication to improve outcomes in biliary atresia, research which is possible because of the generous support from Men of Distinction. In addition, Dr. Harpavat leads a large National Institutes of Health-funded study focused on developing new ways to detect biliary atresia in the newborn period. His team is currently screening newborns throughout Houston and the South Texas region.

## Mary Elizabeth M. Tessier, M.D.

Baylor College of Medicine and Texas Children's Hospital



Dr. Tessier cares for patients at Texas Children's Hospital with both gastrointestinal and liver diseases. She has a particular interest in the role of the microbiome in children with liver disease, particularly biliary atresia. Biliary atresia is a devastating disease during infancy and is the most common diagnosis leading to pediatric liver transplant. Dr. Tessier is currently leading a microbiome study in infants with biliary atresia, which is examining how the microbiome impacts outcomes in this disease. This study is possible due to the generous support of the Men of Distinction. She hopes to find novel ways to treat this disease - which currently has limited treatment options- via manipulation of the microbiome.

## Ennio Tasciotti, Ph.D.

Houston Methodist



Dr. Ennio Tasciotti graduated in Molecular Biology at Scuola Normale Superiore in Pisa in 2000, and earned a PhD in Molecular Medicine in 2005 at the International Center for Genetic Engineering and Biotechnology. In 2006 he accepted a Postdoctoral position at the Department of Biomedical Engineering at the University of Texas' Health Science Center. In 2008 he published his first research on 'multistage nanodelivery system', which becomes a cover story on Nature Nanotechnology and was selected by Nature Medicine as one of the "Top 5 breakthroughs in Nanomedicine".

In 2009 he became an Assistant Professor at the first Department of Nanomedicine in an American Medical School and in 2010 he was recruited by Houston Methodist Research Institute as Chair of the Department of Nanomedicine. Dr. Tasciotti is an Associate Professor of Nanomedicine at the Institute of Academic Medicine, serves as Director of the Center for Biomimetic Medicine at the Department of Regenerative Medicine, and Director of the Center for Musculoskeletal Regeneration at the Department of Orthopedics and Sports Medicine of Houston Methodist Hospital. Dr. Tasciotti holds affiliated and honorary positions in 6 universities in USA, Europe and Asia. His research interests are in the field of biomimetic nanomaterials for drug delivery and tissue engineering.

In his career he received over \$15M by DoD and DARPA to create bioactive nanomaterials to regenerate musculoskeletal tissues, and over \$10M from NIH, NSF, CPRIT and private foundations to develop nanoparticles for drug delivery. He coordinates a multidisciplinary research group of 20 people, has published more than 130 research articles, filed 15 patent applications, contributed to 12 technical books and presented at over 200 international conferences. The main focus of his laboratory is translational research for the development of new surgical and clinical approaches using nanotherapeutics. In particular: 1- Biomimetic materials to improve musculoskeletal tissue regeneration; 2- Artificial biomimetic extracellular matrices to modulate immune response; 3- Bioinspired delivery platforms for the active targeting of inflammation; 4- Nanostructured hydrogels for the localized release of clinically approved drugs.


We are extremely honored that our own Ennio Tasciotti, PhD, was chosen by the Men of Distinction organization as one of this year's three beneficiaries. As Associate Professor of Nanomedicine at Houston Methodist Research Institute and director of our Center for Biomimetic Medicine, he has been investigating the use of nano and biomaterials for drug delivery and regenerative medicine for the past decade.

Funding from Men of Distinction will help support Dr. Tasciotti's research in developing a cardiac patch for the repair of congenital heart defects. His strategy involves fabricating patches while patients are still developing in utero, and using them to deliver a material made from the embryos' own stem cells as a regenerative therapy to treat the heart disease. This promising patch would integrate with surrounding tissues and grow with young patients, alleviating the need for recurring surgeries and greatly improving the overall quality of life for these children.

We are grateful to be among the many worthy Houston institutions the Men of Distinction organization has chosen to support over the years for our contributions in improving health care through medical research.
